CONTINUATION ORDER

WHEREAS, permission u/s15 of NCTE Act, 1993 was granted to the institution namely, **PPG College of Education, No.9/1, Keeranatham Road, Saranatham Road, Saravanampatti Post, Coimbatore-641035, Tamilnadu** run by **P. Perichi Gounder Memorial Charitable Trust, Coimbatore District, Tamilnadu** vide (NCTE) order no.F.SRO/NCTE/M.Ed/2006-2007/14218 dated 06.11.2007 for conducting **M.Ed. Course** of one year duration with an annual intake of 25 students.

2. **AND WHEREAS**, enhancement of intake of 10 seats from 25 to 35 was permitted vide order no F.SRO/NCTE/2010-2011/20657 to the institution on 24.08.2010.

3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt.20.01.2015 for its willingness of two units in M.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 25.05.2015 for conducting **M.Ed. programme of two years duration with an annual intake of 50 (one unit) from the academic session 2015-16.**

4. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice issued on 28.08.2019. The institution vide letter dated 25.09.2019 has submitted a reply to the Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 388th Meeting held on 14th & 15th September, 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with the requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 20.04.2022. The institution has submitted a reply to the Show Cause Notice on 01.07.2022.

6. **AND WHEREAS**, the SRC in its 412th Meeting held on 05th & 06th July 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **PPG College of Education for Women, Survey No 9/1, Keeranatham Road, Saravanampatti post, Coimbatore-641035, Tamilnadu** for **M.Ed. programme for 1 basic unit of 50 students** subject to the condition on submission of an Affidavit on Rs.100/- Non Judicial Stamp paper clearly mentioning the name and account number of each of the faculty appointed for M.Ed. programme and also stating therein that the faculty are being paid salary through cheque/RTGS/NEFT. The Affidavit should be supported with documents like photocopy*

of passbook of each of faculty showing the disbursement of salary through bank account to individual faculty members (at-least for 3 months). After receipt of the same the RD, SRC is advised to issue continuation order only after obtaining the above required documents”.

7. **AND WHEREAS**, as per decision of SRC, a letter was issued to the institution on 26.07.2022. The institution has submitted a reply on 26.07.2022 to the letter according to bank statement salary is being disbursed through bank to faculty.

8. **NOW THEREFORE**, this order is issued permitting the institution i.e., **PPG College of Education for Women, Survey No 9/1, Keeranatham Road, Saravanampatti post, Coimbatore-641035, Tamilnadu** run by **P. Perichi Gounder Memorial Charitable Trust, Ashwin Hospital Campus, Sathy Main Road, Coimbatore-641012, Tamilnadu** for Continuation of recognition for **M.Ed. programme** for two years duration with an annual intake of **1 basic units of 50 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

10. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.

- e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
13. The institution shall make available the list of students admitted on its official website.
14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
